Dear Sir or Madam,

Through the continuous monitoring of the products distributed by Mindray, we have become aware of a potential issue associated with the Total Prostate Specific Antigen (CLIA) kits. This letter is intended to provide you with information as following:

Details on affected products:

The affected products are listed in **Table 1** and the method of identifying the affected kits is explained in **Appendix 1**.

Description of the problem:

Mindray has identified that TPSA kits of a different lot were mistakenly packaged into a limited number of TPSA 2x50T kits of LOT 2019030100. Both lots are of good quality. However, due to lot-to-lot variation, mixing two lots of reagent kits may cause out-of-acceptable-range control results or abnormal results (increased or decreased) of patient samples if the user is unaware of the issue.

To date, there are no reports of serious incident associated with this potential issue.

Advise on actions to be taken by the Hospital/Laboratory administrator:

- Please pass this Notice to all those who need to be aware of the issue within your organization or to any organization where the potentially affected reagent kits have been transferred.
- 2. Please discontinue to use and discard the affected kits listed in Table 1. Your local Mindray Service Representative will contact you as soon as possible to replace the affected reagent kits.

Advise on actions to be taken by the distributor:

- 1. Please pass this Notice to all those who need to be aware of the issue within your organization or to any organization where the potentially affected reagent kits have been delivered.
- 2. Please do not sell these affected reagent kits to customers. Mindray Regional Product Specialist will contact you to replace the affected reagent kits.
