Dear Ladies and Gentlemen,

The purpose of this letter is to inform you, that we created new kit files for the above-mentioned product lots.

<u>Reason:</u>

It was observed that the mix NX-C-41-M2 (position G11 in plate A in HLA-FluoGene^{NX} Match and HLA-FluoGene^{NX} ABCDRDQ) showed a false positive reaction in presence of the homozygous genotype C*06:02:01:01. This leads to the wrong heterozygous result C*06:02:01:01 / C*12:04:01. The latter is according to CWD-2.0 a well-documented allele.

The investigation of the cause gave the following result:

In quality controls, the affected mix has been tested more than 100 times for correct negativity. Only occasionally low background signals were observed.

Nevertheless, a complaint and internal tests later on showed high background signals with a tendency to false positivity.

Field Safety Corrective Action (FSCA):

As a correction, we changed the expected reaction behavior of the allele C*06:02:01:01 in the affected primer-probe-mix from negative to questionable in the FluoGene software. Doing this we created new kit files for the above-mentioned lots.

Direction for the user / general statement:

For further evaluation of the above-mentioned products with the respective lots, the use of the relevant new kit file is necessary.

Import of the revised kit file:

Please import the new kit file (see below) in the FluoGene Software as usual. Thereupon only the revised lot number is available to create a new job. The previous version is automatically set to inactive. Already processed analyses with the previous kit file remain untouched in the FluoGene Software.

The risk to the patient is considered low due to the low frequency of this event, and the additional risk reduction achieved through application of the requirements and limitations described in the product insert. Results from these kits are not to be used as the sole basis upon which a clinical decision affecting the patient is made. Due to the complex nature of HLA typing, qualified personnel should review data interpretation and typing assignments, as per the limitations of the procedure section of the product insert.
